A RESOLUTION OF THE BOARD OF DIRECTORS OF THE CALIFORNIA PINES COMMUNITY SERVICES DISTRICT ESTABLISHING ACCESS TO 2 YD DUMPSTERS TO CUSTOMERS WITHIN CSD JURISDICTION

**BE IT RESOLVED;** the California Pines Community Service District has in its possession 2 dumpsters and will provide 2 cubic yard Dumpster for Customers in the lake units. Dumpsters are intended for household garbage during the moving process, for general property clean-ups and/ or Construction/Renovation Projects. All trash must fit inside the dumpster for the district to be able to pick up.

**WHEREAS** the district will allow customers a dumpster on a weekly basis, up to 2 weeks at a time not to exceed 2 times in a calendar year. This can be in addition to or in lieu of regular trash service provided by the district.

**BE IT ALSO RESOLVED,** A schedule of charges for this service will be \$10.00 per week for the dumpster and \$28.66 per dump of said dumpster. These charges are subject to change. Deposit will be required before dumpsters are delivered. Dumpsters will only be delivered, dumped, and/or returned to the district yard on regular trash days (typically Mondays).

**THEREFORE IT IS RESOLVED,** that the California Pines Community Service District Board of Directors agreed on providing 2 Yard dumpster with applicable charges to customers within our jurisdiction.
