PUBLIC HEARINGS:

ITEM 2: A RESOLUTION OF THE BOARD OF DIRECTORS OF THE CALIFORNIA PINES COMMUNITY SERVICES DISTRICT, APPROVING THE CALIFORNIA PINES COMMUNITY SERVICES DISTRICT SERVICES SPECIAL PARCEL TAX MEASURE, WHICH WOULD INCREASE THE DISTRICT'S SPECIAL PARCEL TAX FOR DISTRICT SERVICES FROM \$66 TO \$116 PER YEAR FOR EACH PARCEL ON WHICH THE TAX IS LEVIED, AND ORDERING THE SUBMITTAL OF SAID MEASURE TO THE VOTERS AT THE GENERAL DISTRICT ELECTION TO BE HELD ON NOVEMBER 3, 2026

ITEM 3: A RESOLUTION OF THE BOARD OF DIRECTORS OF THE CALIFORNIA PINES COMMUNITY SERVICES DISTRICT, APPROVING THE CALIFORNIA PINES COMMUNITY SERVICES DISTRICT FIRE SERVICES SPECIAL PARCEL TAX MEASURE, WHICH WOULD INCREASE THE DISTRICT'S SPECIAL PARCEL TAX FOR FIRE PROTECTION AND PREVENTION SERVICES FROM \$25 TO \$75 PER YEAR FOR



EACH PARCEL ON WHICH THE TAX IS LEVIED, AND ORDERING THE SUBMITTAL OF SAID MEASURE TO THE VOTERS AT THE GENERAL DISTRICT ELECTION TO BE HELD ON NOVEMBER 3, 2026
