***ITEM 1: A RESOLUTION OF THE BOARD OF DIRECTORS OF THE CALIFORNIA PINES COMMUNITY SERVICES DISTRICT CALLING AND PROVIDING FOR A SPECIAL DISTRICT MAIL BALLOT ELECTION TO BE HELD ON TUESDAY, MAY 6, 2025 FOR THE SUBMITTAL OF ONE OR MORE SPECIAL PARCEL TAX BALLOT MEASURES TO THE VOTERS***

***ITEM 3: A RESOLUTION OF THE BOARD OF DIRECTORS OF THE CALIFORNIA PINES COMMUNITY SERVICES DISTRICT, APPROVING THE CALIFORNIA PINES COMMUNITY SERVICES DISTRICT SERVICES SPECIAL PARCEL TAX MEASURE, WHICH WOULD INCREASE THE DISTRICT'S SPECIAL PARCEL TAX FOR DISTRICT SERVICES FROM \$66 TO \$116 PER YEAR FOR EACH PARCEL ON WHICH THE TAX IS LEVIED, AND ORDERING THE SUBMITTAL OF SAID MEASURE TO THE VOTERS AT THE SPECIAL DISTRICT ELECTION TO BE HELD ON MAY 6, 2025***
