- Approximately 85% of Road Maintenance for 2024 is complete.
- Lot mow to commence this month, starting with district-owned properties and moving on to privately owned parcels in mid to late July.
- Scheduled Water digs are coming up at the end of this month.
- Expected Grant Updates and possible leads on CRWA-based grants are upcoming in the next few weeks.
- Accepting and Exploring quotes and options for sludge dredging of sewer ponds.
- Upgrades to Sewer Pumps and Lift Stations are being considered. As foreign material in sewer infrastructure has increased lately, sewer customers will receive reminders about what is and is not allowed in the sewer. Maintenance is costly and can disrupt the system for periods of time. A sustainable solution is needed as each incident can cost the district thousands of dollars, if not tens of thousands.
